**ANNUAL PASS CLASSIFICATIONS**

- 1. 7 Day Pass Holder | 12-month access to green fees and practice facilities Monday – Sunday  
(When space is available, Holidays included)
- 2. 5 Day Pass Holder | 12-month access to golf course and practice facilities Monday – Friday  
(When space is available, Holidays NOT included)
- 3. Snowbird Pass Holder | 6-month access to golf course and practice facilities Monday – Friday  
(When space is available, Holidays NOT included)
- 4. Unlimited Cart Usage | Unlimited cart usage expires on the same date as Annual Pass. Cart usage is good ONLY for the Pass Holder. Guests of Annual Pass Holders must pay for ½ cart rental each time they play.
- 5. Trail Fee | All Pass Holders who own and use a personal golf cart at OGA Golf Course must pay the Trail Fee.

Annual Pass includes green fees and use of the practice range (*all based on availability*). Cart usage is included for the annual pass holder only, additional riders not included in annual fee. Range use and tokens are for the pass holder only and are not to be shared with pass holders. Abuse of any of these privileges may result in suspension and/or non-refundable termination of your annual pass.

This agreement between the applicant and the OGA Golf Course Inc. constitutes an agreement between the two parties. The 2021 Annual Pass does not constitute equity in the OGA Golf Course. OGA Golf Course Inc. reserves the right to modify these rules, terms and conditions, or to terminate this agreement at any time without notification or explanation. The 2021 Annual Pass is non-transferrable and non-refundable. All pass holders will use the facility at their own risk and must abide by club rules at all times.

The Annual Pass includes member charging privileges in both Orchards Grill and the Golf Shop with a \$500 credit limit. Pass holders must provide valid CC# for monthly payment of A/R Balance. The undersigned hereby agrees to pay all costs of collections, including reasonable attorney fees, if this account is not paid within 90 days of the statement date. The undersigned further agrees to pay interest on the past due balance at the greater of one and one-half percent (1 ½%) per month. (Annual percentage rate of eighteen percent (18%), or the maximum permitted under applicable law. By signing this agreement, the applicant(s) agrees to the terms and conditions which are listed, and agrees to abide by them.

**Payment Default:** If the Annual Pass Holder fails to pay any amount when due under the agreement, OGA Golf Course shall be entitled, at any time in its sole discretion to suspend or cancel the Annual Pass Holder's privileges and to require the Annual Pass Holder to immediately pay all past due balances, and to accelerate all future Annual Pass dues. Suspension or cancellation shall not relieve the Annual Pass Holder from the obligation to pay all unpaid balances. Any payments owed to OGA Golf Course that are not received when due shall bear interest at the highest interest rate permitted by law. If the Annual Pass Holder fails to pay OGA Golf Course when due, the Annual Pass Holder shall pay all costs and expenses of collection including reasonable attorney's fees incurred by OGA Golf Course.

**Miscellaneous:** This Agreement shall be governed by the internal laws of the State of Oregon. This Agreement shall be binding upon and inure to the benefits of the parties hereto and their respective heirs, successors and permitted assigns. This Agreement and the rights and obligations hereunder shall not be assignable or transferable by the Annual Pass Holder without the prior written consent of OGA Golf Course. Consent may be withheld in OGA Golf Courses absolute discretion. If any term or provision of the Agreement is declared to be illegal, invalid or unenforceable shall not affect the validity of the remainder of the Agreement, and to the extent permitted by applicable laws, any such term or provision shall be restricted in applicability
